Wolf Creek Kennels Boarding and Legal Policies
*** Please Read and Initial Each Section ***

1. $\qquad$ Wolf Creek Kennels reserves the right to immediately change your pet's type of boarding or daycare if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff, and Owner agrees to pay any additional costs associated with the change.
2. $\qquad$ Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from your vet before starting daycare, training or boarding.
$\qquad$ Owner agrees that the pet shall not leave the kennel until all charges are paid in full to Wolf Creek Kennels.
3. $\qquad$ Owner agrees to be solely responsible for any and all acts or behavior of Owner's pet while it is in the care of Wolf Creek Kennels.
4. $\qquad$ Owner specifically represents that they are the lawful and valid owner of the pet, free and clear of all liens and encumbrances.
5. $\qquad$ Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
6. $\qquad$ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, Wolf Creek Kennels may exercise its lawful rights upon ten (10) days written notice by delivering such notice via first-class mail to Owner's Address. A pet that is unclaimed at Wolf Creek Kennels for ten (10) days beyond its scheduled discharge date is considered abandoned and will become the property of Wolf Creek Kennels. Every effort will be made to contact Owner if abandonment becomes an issue. If for any reason the pet is not going to be picked up on the scheduled dismissal date, Owner shall contact Wolf Creek Kennels
to make arrangements to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.
7. $\qquad$ If the pet becomes ill or if the state of the animal's health otherwise requires attention, Wolf Creek Kennels at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including $\$ 500.00$. If a veterinarian determines that emergency treatment, which Exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal.
8. $\qquad$ Owner understands that all training programs are only expected to improve the dog's obedience. It is the Owner's responsibility to reinforce and to advance the dog's behavior and obedience after the dog's scheduled training at Wolf Creek Kennels.
9. $\qquad$ Owner agrees to release, indemnify, and hold harmless Wolf Creek Kennels from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Wolf Creek Kennels' services, except which may arise from the gross negligence or intentional and willful misconduct of Wolf Creek Kennels.
10. $\qquad$ This Agreement shall be governed by and construed in accordance with the laws of the State of Michigan. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the State of Michigan. Owner and Wolf Creek Kennels must negotiate and mediate in good faith prior to either party filing a cause of action.
11. $\qquad$ Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of Owner and Wolf Creek Kennels.
